ORDER

09.04.2018- This appeal has been listed on urgent mentioning by the authorised Officer of Union of India in presence of learned counsel for 5th, 6th, 7th & 8th Respondents, some of whom have appeared by filing Caveat. Taking into the nature of the case, we directed to list the case for admission.

2. The question arises for consideration in this appeal is whether the National Company Law Tribunal (hereinafter referred to as "Tribunal")

is justified in giving a finding in regard to 44th, 51st, 52nd and 53rd Respondents of the Company Petition that they are innocent in an application for vacating the interim order of the stay without going into merit of the Company Petition. The other question relates to withdrawal of amount by 35th and 38th Respondents of the Company Petition by modifying the interim order dated 23rd February, 2018, though the Tribunal accepts that a *prima facie* case has been made out against them.

- 3. The Appellant-Union of India filed an application under Sections 241(2) and 242 read with other provisions of the Companies Act, 2013, alleging that the affairs of the 1st Respondent Company- "Gitanjali Gems Limited", its group companies and LLPs have been/being conducted prejudicial to public interest of India. In the said petition, an interim order was passed by the Tribunal on 23rd February, 2018, relevant portion of which reads as follows:
 - "8. The Petitioner has candidly said that if notice has been given to the parties prior to hearing then there is every possibility of consuming time for effecting service in view of the exigency involved in this case, the Petitioner in view of the public interest has sought for ex-parte orders, for this Bench having noticed that the Petitioner has established prime facie case for

asking ex-parte orders, this Bench has passed this ex-parte order.

- 9. In view of the same, this Bench, by invoking section 221 of the Companies Act, 2013 and section 43 of LLP Act, 2008, hereby injunct the Respondents and other companies, LLPs, Trusts and individuals mentioned above from removal, transfer or disposal of funds, assets and properties of the entities and individuals mentioned above until further orders."
- 4. In the said petition, a number of applications were filed by the contesting Respondents for modification/vacation of the interim order wherein in respect of four Respondents aforesaid, the interim order has been vacated by the Tribunal giving a finding that they are innocent without going into the merit or public interest. With regard to the other two Respondents, the interim order has been modified by allowing them to withdraw certain amount from their Bank account.
- 5. Taking into consideration the nature of the case, we direct to issue notice on Respondents. The 5th, 6th, 7th & 8th Respondents have appeared, no further notice need be issued to them. They may file their reply within ten days.
- 6. Let notice be issued on rest of the Respondents. Requisite along with process fee, if not filed, be filed by 10th April, 2018. If the Appellant

provides the e-mail address of rest of the Respondents, let notice be also issued through e-mail. The Appellant will serve a copy of the paper book on each of the Respondents or their counsel separately.

Post the matter on 23rd April, 2018.

7. Until further orders, the operation of the impugned order dated 2nd April, 2018 passed in the connected miscellaneous application in Company Petition No. 277 of 2018 shall remain stayed.
