ORDER

18.04.2018- Apart from other questions, the question arises for consideration in this appeal is whether application under Section 9 of the Insolvency and Bankruptcy Code, 2016 (hereinafter referred to as "I&B Code") can be entertained while petition under section 11(6) of the Arbitration Act, 1996 is pending before the Hon'ble High Court. In other words, whether an application under Section 11(6) of the Arbitration Act, 1996 amounts to pendency of an arbitral proceeding. If it does not amount to pendency of an arbitral proceeding, in such case, can it be treated to be existence of a dispute for refusing an application under Section 9 of the 'I&B Code'.
