# <u>O R D E R</u>

**19.04.2018-** Apart from the other questions, the questions arise for consideration in these appeals are:

- What is the intention of the legislature in allowing the (suspended) Board of Directors to attend the meeting of Committee of Creditors? and
- ii. If any person including the Directors or other who are otherwise ineligible under Section 29(A) offers better amount for 'Resolution Process' can such offer be rejected on the ground that they are ineligible, though, the Code has been enacted with a view to maximise the value of assets of the corporate person. In other words, whether Section 29 (A) is mandatory or not?

Respondent(s) are allowed to file reply within 10 days. Rejoinder, if any, be filed by the Appellant(s) within five days thereof.
