ORDER

O3.08.2017 In these appeals including the appeals preferred by *Binani Cement Limited [TA (AT) (Compt.) Nos. 28 and 29 of 2017 (Old Appeal Nos. 68/2016 and 69 of 2016)]* the Appellate Tribunal on the request of the learned counsel for the appellants, passed the following interim order on 24th May, 2017:

"Learned counsel for the Appellant Dr. Manish Singhvi requests time of six months for depositing 10% of the penalty amount as directed by this Tribunal on 28.11.2016.

We have perused the Interim Application Nos. 38/2017 and 42/2017 and reply filed by the Commission. The Act stipulates a period of six months, within which in the normal course appeals before this Tribunal should be decided. Therefore, what learned counsel has asked for is, in effect waiver

of the order of this Tribunal dated 28.11.2016. We cannot agree to such a proposition. We are further conscious of the fact that through this process of interim applications, the appellant has already taken a time of almost six months and yet not complied with the Tribunal's order of 28.11.2016. Learned counsel for the Commission Shri Gaggar objects to any further time being granted to the appellants.

As a matter of last opportunity, we allow a period up till 12th July, 2017, when the bunch of similar cases are fixed for final arguments, to the appellant to deposit 10% of the penalty in accordance with the order dated 28.11.2016, failing which the appeal shall be considered as dismissed without referring back to the Tribunal. If the Appellant deposits 10% of the penalty as directed, the case be listed for arguments with other similar cases."

In spite of the aforesaid order, the appellant – Binani Cement Ltd., in both the appeals, have not deposited the amount. Ms. Sagarika Rawat, Advocate appearing on behalf of Binani Cement Ltd. referred to an order passed by the learned Adjudicating Authority (National Company law Tribunal, Kolkata Bench, Kolkata) on 25th July, 2017 in C.P. (IB) No. 359/KB/2017 where an Interim Resolution Professional (IRP) has been appointed and Insolvency Resolution has been started against appellant – Binani Cement Limited.

Now, in view of the aforesaid development as the amount can be recovered only through the Resolution Process, if the appeals fail, we allow the respondent – Competition Commission of India to lodge its claim before the IRP, who in his turn will consider the claim along with other creditors.

Heard Mr. C.A. Sundaram, learned Senior Counsel appearing on behalf of some of the appellants. Hearing remained inconclusive.
