In the meantime, the Resolution Professional will file a report enclosing a chart for perusal of this Appellate Tribunal showing the offer made by the three Resolution Applicants, in its monetary terms (Matrix) and the liquidation value of the Corporate Debtor. He will also state as to whether they have calculated the value of the land for the purpose of calculating liquidation value and if so, they will state whether the land belongs to the Corporate Debtor or somebody else. They will also indicate that if it is lease hold land, whether lease agreement reached its final stage before the initiation of the Corporate Insolvency Resolution Process.
