As the Interlocutory Application is the conditional one, we are not inclined to pass any specific order, particularly, as the matter is also pending

before the Hon'ble Supreme court. However, on the oral request of the learned counsel for the appellant, we allow the 'Appellant' and the other 'Resolution Applicants' to file additional unconditional 'resolution plans' by 13<sup>th</sup> August, 2018 improving the 'financial offer' without compromising the basic para-meters of the 'resolution plans' already submitted by them. In such case additional plans will be treated to the part of their respective 'original resolution plans'.

I.A. No. 1154 stands disposed of.
