<u>O R D E R</u>

29.08.2018 - Referring to a report of the DG, the appellant submitted that the DG has only reported that Hetero Healthcare Ltd would continue supplies to IP-1but would not appoint it as a stockist without NOC. It is submitted that there is no cartel on the part of the appellant.

Let notice be issued on respondents. Requisites alongwith process fee, if not filed, be filed by 31.8.2018. If the appellant provides the email address of the respondents, let notice be also issued through email.

In the meantime, the impugned order dated 12.7.2018, so far it relates to imposition of penalty on appellant(s), shall remain stayed subject to payment of 10% of the penalty mount as imposed on respective appellants by way of FDR in favour of Registrar, NCLAT within two weeks.

Post these appeals for admission on 24th September, 2018 when similar matters are likely to be listed.
