ORDER

06.12.2017- Learned counsel for the appellant submits that the impugned order dated 19th September, 2017 has been passed by the National Company Law Tribunal, Mumbai Bench, Mumbai in a Company Application preferred by Respondent Nos 3 to 5 wherein no such relief has been sought for as mentioned in the opening paragraph of the impugned order.
