In the meantime, the State of Jharkhand has filed Interlocutory Application Nos. 801-803 of 2018 in Company Appeal (AT) (Insolvency) No. 175 of 2018 and 804-806 of 2018 in Company Appeal (AT) (Insolvency) No. 223 of 2018 for direction and clarification against the order passed by the Adjudicating Authority (National Company Law Tribunal) on the day the impugned order approving the 'Resolution Plan' of the successful 'Resolution Applicant'- ('Vedanta Limited') was passed.
- 3. It is submitted that the land which belongs to the State of Jharkhand, including the forest land has been included in the 'Resolution Plan' as the 'Resolution Professional' has wrongly shown it as a land of 'Corporate Debtor'.
- 4. Mr. Gaurav Banerjee, learned Senior Counsel appearing on behalf of the 'Resolution Professional' and Mr. Arun Kathpalia, learned Senior Counsel for the successful 'Resolution Applicant' submits that the State of Jharkhand took similar plea in the suit against the predecessor of the 'Corporate Debtor' which has been dismissed.
- 5. However, according to Mr. Tapesh Kumar Singh, learned Senior Counsel for the State of Jharkhand, the land belongs to the State of Jharkhand and notification declaring the land as forest land was issued as back as in the year 1958.

6. Having heard learned counsel for the parties after reserving the

judgment, it is not desirable to implead the 'State of Jharkhand' as party

Respondent for the present, however, while delivering the judgment we

consider the issue taking into consideration stand taken by the parties

and will pass appropriate order on the subject matter.

Appeal (AT) (Insolvency) No. 175 of 2018 and 804-806 of 2018 in

Company Appeal (AT) (Insolvency) No. 223 of 2018 stand disposed of.
