#### ORDER

**09.07.2018:** In Company Appeal (AT) (Insolvency) No. 147 of 2018, there is a dispute about the debt. The Appellant – "Orissa Sales" (Operational Creditor) pleaded that they suppled hardware and electric goods to "Gammon India Ltd." (Corporate Debtor) during the period 01.04.2012 to 20.11.2015. The Operational Creditor relied on the balance confirmation letter dated 20.11.2015 (at page 74) to suggest that the Corporate Debtor also accepted the dues.

The Adjudicating Authority noticed the stand taken by the Corporate Debtor that all those dues were paid. However, no evidence cited in the impugned order.

Mr. Rudreshwar Singh, learned counsel appearing on behalf of the Corporate Debtor submits that the amount was paid by RTGS and other instruments. We allow him 10 days' time to file an affidavit showing the details of payment made in terms of confirmation letter dated 20.11.2015 (page 74).

Place the case 'for admission' on 27th July, 2018.

All the other appeals will be taken on the same date. Reply may be filed by the Respondent (Corporate Debtor) in other appeals also.
