### **ORDER**

**25.06.2018** Impleadment application has been filed on behalf of Divisional Forest Officer, Bokaro Forest Division, Department of Forests & Environment and Climate Bench, Government of Jharkhand, Bokaro whose land is alleged to have been included in the Resolution Plan by the Resolution Applicant which has been noticed by Adjudicating Authority (National Company Law Tribunal), Kolkata Bench in its order dated 17<sup>th</sup> April, 2018 passed in CA(IB) No. 307/KB/2018.

Both the Appeals i.e., Company Appeal (AT)(Insolvency) No. 175 of 2018 and Company Appeal (AT)(Insolvency) No. 223 of 2018 were heard by another Bench and judgment has already been reserved.
