**O R D E R**

**22.05.2018-** Mr. Rajiv Nayar, learned Senior Counsel along with Mr. V.P. Singh and Ms. Ruby Ahuja, Advocates submits that they intend to appear on behalf of 'Tata Steel Limited' which has been declared successful 'Resolution Applicants' and its 'Resolution Plan' has been approved by the 'Committee of Creditors' and the Adjudicating Authority.

Rejoinder, if any, may be filed by the Appellant by 29<sup>th</sup> May, 2018.

Post the appeal for admission on 30<sup>th</sup> May, 2018 along with Company Appeal (AT) (Insolvency) No. 221 of 2018.

In the meantime, counsel for the Appellant will file certified copy of the impugned order dated 15<sup>th</sup> May, 2018.
